### **I. Situation Overview**

On 02 February 2025 at around 1:00 PM, a fire incident occurred at Purok Tonggoy in Brgy. Mandalagan, Bacolod City, Negros Occidental.

### **IV. Damaged Houses**

**One (1) house** was **partially damaged** in **Brgy. Mandalagan, Bacolod City, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱9,182.00** worth of assistance was provided to the affected family; of which, **₱4,892.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
