### I. Situation Overview

On 16 December 2024 at around 1:30 AM, a fire incident occurred in Brgy. Masaling, Cauayan, Negros Occidental.

**One (1) family** or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

One (1) house was totally damaged in Brgy. Masaling, Cauayan, Negros Occidental (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of ₱9,165.00 worth of assistance was provided to the affected family; of which, ₱6,165.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
