

DSWD DROMIC Report on the Fire Incident in Brgy. Mat-i, Surigao City, Surigao del Norte

11 February 2025, 6PM

I. Situation Overview

On 08 February 2025 at around 11:00 AM, a fire incident occurred in Brgy. Mat-i, Surigao City, Surigao del Norte. The fire was declared out at around 11:30 AM.

One (1) family or **four (4) persons** were affected in **Brgy. Mat-i, Surigao City, Surigao del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Mat-i, Surigao City, Surigao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱40,308.55** worth of assistance was provided to the affected family; of which, **₱39,558.55** from **DSWD** and **₱750.00** from the **Local Government Unit (LGU)** (see Annex D).
