I. Situation Overview

On 14 December 2024 at around 8:58 AM, a fire incident occurred in Brgy. Maybocog, Maydolong, Eastern Samar. The fire was declared out at around 9:20 AM.

One (1) house was **totally damaged** in **Brgy. Maybocog, Maydolong, Eastern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,512.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
