I. Situation Overview

On 01 February 2025 at around 1:30 PM, a fire incident occurred in Brgy. Naisud, Ibajay, Aklan. The fire was declared out at around 3:00 PM.

One (1) family or **six (6) persons** were affected in **Brgy. Naisud, Ibajay, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Naisud, Ibajay, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,788.00** worth of assistance was provided to the affected family; of which, **₱6,198.00** from **DSWD** and **₱1,590.00** from the **Local Government Unit (LGU)** (see Annex D).
