## I. Situation Overview

On 31 January 2025 at around 7:10 PM, a fire incident occurred in Brgy. Nasapahan, Lemery, Iloilo. The fire was declared out at around 8:00 PM.

One (1) **family** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

#### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Nasapahan, Lemery, Iloilo** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱10,466.00 worth of assistance was provided to the affected family; of which, ₱6,466.00 from DSWD and ₱4,000.00 from the Local Government Unit (LGU) (see Annex D).
