

## DSWD DROMIC Report on the Fire Incident in Brgy. Nasapahan, Lemery, Iloilo

21 February 2025, 6PM

### I. Situation Overview

On 31 January 2025 at around 7:10 PM, a fire incident occurred in Brgy. Nasapahan, Lemery, Iloilo. The fire was declared out at around 8:00 PM.

**One (1) family or five (5) persons** were affected in **Brgy. Nasapahan, Lemery, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

One (1) **family or five (5) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Nasapahan, Lemery, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,466.00** worth of assistance was provided to the affected family; of which, **₱6,466.00** from **DSWD** and **₱4,000.00** from the **Local Government Unit (LGU)** (see Annex D).
