

DSWD DROMIC Report on the Fire Incident in Brgy. No. 2 San Andres I, Bacarra, Ilocos Norte

12 February 2025, 6AM

I. Situation Overview

On 30 January 2025 at around 4:00 PM, a fire incident occurred in Brgy. No. 2 San Andres I, Bacarra, Ilocos Norte.

One (1) family or 4 persons were affected in **Brgy. No. 2 San Andres I, Bacarra, Ilocos Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or 4 persons are currently staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. No. 2 San Andres I, Bacarra, Ilocos Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱24,200.05** worth of assistance was provided to the affected family; of which, **₱21,200.05** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
