

DSWD DROMIC Report on the Fire Incident in Brgy. Paticui, Hinigaran, Negros Occidental

25 February 2025, 6PM

I. Situation Overview

On 18 February 2025 at around 2:30 PM, a fire incident occurred at Purok Pag-asa, Brgy. Paticui, Hinigaran, Negros Occidental.

As a result of the incident, two (2) individuals were affected. In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in collaboration with the Local Government Unit (LGU), provided them assistance to address their immediate needs.

One (1) family or two (2) persons were affected in **Brgy. Paticui, Hinigaran, Negros Occidental** (see Annex A).

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Paticui, Hinigaran, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,486.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
