### I. Situation Overview

On 16 January 2025 at around 3:21 PM, a fire incident occurred in Brgy. Poblacion llawod, City of Passi, lloilo. The fire was declared out at around 4:00 PM.

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

A total of two (2) houses were totally damaged in Brgy. Poblacion Ilawod, City of Passi, Iloilo (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱33,296.00 worth of assistance was provided to the affected families; of which, ₱13,296.00 from DSWD and ₱20,000.00 from the Local Government Unit (LGU) (see Annex D).
