

## **DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion, Kabugao, Apayao**

24 February 2025, 6PM

### **I. Situation Overview**

On 28 January 2025 at around 9:00 PM, a fire incident occurred in Sitio Landing, Brgy. Poblacion, Kabugao, Apayao.

As a result of the incident, five (5) individuals were affected. In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) Cordillera Administrative Region (CAR) and the Local Government Unit (LGU) provided them relief assistance to address their immediate needs.

**One (1) family or five (5) persons** were affected in **Brgy. Poblacion, Kabugao, Apayao** (see Annex A).

#### **Outside Evacuation Center**

**One (1) family or five (5) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Poblacion, Kabugao, Apayao** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱31,543.20** worth of assistance was provided to the affected family composed of **₱21,543.20** from **DSWD** and **₱10,000.00** from the **LGU** (see Annex D).
