I. Situation Overview

On 03 February 2025 at around 1:45 PM, a fire incident occurred at Purok 3, Brgy. Punta, Liloy, Zamboanga del Norte. The fire was declared out at around 2:01 PM.

V. Cost of Humanitarian Assistance Provided

A total of **₱2,083.50** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
