I. Situation Overview

On 02 February 2025 at around 2:46 PM, a fire incident occurred at Purok Gumamela, San Jose, Pagadian City, Zamboanga del Sur. The fire was declared out at around 3:30 PM.

A total of **seven (7) families** or **36 persons** were affected in **Brgy. San Jose, Pagadian City** (see Annex A).

Outside Evacuation Center

A total of **seven (7) families** or **36 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **five (5) houses** were damaged; of which, **four (4)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. San Jose, Pagadian City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,010.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
