## I. Situation Overview

On 02 February 2025 at around 2:46 PM, a fire incident occurred at Purok Gumamela, San Jose, Pagadian City, Zamboanga del Sur. The fire was declared out at around 3:30 PM.

A total of **seven (7) families** or **36 persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

A total of five (5) houses were damaged; of which, four (4) are totally damaged and one (1) is partially damaged in Brgy. San Jose, Pagadian City (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **P15,010.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
