I. Situation Overview

On 18 January 2025 at around 5:10 PM, a fire incident occurred at Zone 1, Purok Villa Esperanza, Brgy. Tangub, Bacolod City, Negros Occidental.

One (1) family or five (5) persons were affected in **Brgy. Tangub, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Tangub, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,437.44** worth of assistance was provided to the affected families; of which, **₱5,147.44** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
