

DSWD DROMIC Report on the Fire Incident in Brgy. Villamonte, Bacolod City

I. Situation Overview

On 29 January 2025 at around 11:00 AM, a fire incident occurred at Purok Malvar Cubay, Brgy. Villamonte, Bacolod City, Negros Occidental.

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Villamonte, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,437.44** worth of assistance was provided to the affected family; of which, **₱5,147.44** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
