

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 05, San Policarpo, Eastern Samar

23 March 2025, 6PM

I. Situation Overview

On 05 February 2025 at around 8:45 AM, a fire incident occurred at Brgy. 05, San Policarpo, Eastern Samar. The fire was declared out at around 9:45 AM. Due to this, five (5) individuals were affected, resulting in significant damages to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VIII, together with the Local Government Unit (LGU) of San Policarpo, Eastern Samar, provided relief augmentation and financial assistance through Assistance to Individuals in Crisis Situations to support the immediate needs of the affected family.

One (1) family or **five (5) persons** were affected in **Brgy. 05, San Policarpo, Eastern Samar** (see Annex A).

III. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 05, San Policarpo, Eastern Samar**(see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱38,677.50** worth of assistance was provided to the affected family; of which, **₱18,677.50** from **DSWD** and **₱20,000.00** from the **LGU** (see Annex C).
