

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 123, Tondo, Manila City

16 February 2025, 6PM

I. Situation Overview

On 06 January 2025 at around 2:07 PM, a fire incident occurred at C.P. Garcia St., Brgy. 123, Tondo, Manila City. The fire was declared out at around 3:15 PM.

I. Status of Affected Areas and Population

A total of **124 families** or **464 persons** were affected in **Brgy. 123, Tondo, Manila City** (see Annex A).

II. Status of Displaced Population

a. Inside Evacuation Center

A total of **46 families** or **184 persons** sought temporary shelter at the **Brgy. 123 Covered Court** in **Tondo, Manila City** (see Annex B).

b. Outside Evacuation Center

A total of **78 families** or **280 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of **124 families** or **464 persons** were displaced in **Brgy. 123**, **Tondo**, **Manila City** (see Annex D).

III. Damaged Houses

A total of **29 houses** were **totally damaged** in **Brgy. 123, Tondo, Manila City** (see Annex E).

IV. Cost of Humanitarian Assistance Provided

A total of **P91,478.52** worth of assistance was provided by **DSWD** to the affected families (see Annex F).
