

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 458, Sampaloc, Manila City

23 February 2025, 6PM

I. Situation Overview

On 16 January 2025 at around 5:08 AM, a fire incident occurred at Sulucan St., Brgy. 458, Sampaloc, Manila City. The fire was declared out at around 6:58 AM.

The validation results revealed a total of 100 houses that were completely destroyed. Additionally, the incident has resulted in the displacement of 320 families, comprising 1,074 individuals. Of these, 20 individuals were identified as solo renters.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in the National Capital Region, provided intervention in support to the immediate needs of the affected populace by means of relief assistance.

A total of **320 families** or **1,074 persons** are affected in **Brgy. 458, Sampaloc, Manila City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **320 families** or **1,074 persons** sought temporary shelter in **Brgy. 458 Open Court** in **Brgy. 458, Sampaloc, Manila City** (see Annex B).

IV. Damaged Houses

A total of **100 houses** were **totally damaged** in **Brgy. 458, Sampaloc, Manila City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱419,840.00 worth of assistance was provided by **DSWD** to the affected families (see Annex D).
