

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Guizo, Mandaue City

05 February 2025, 6AM

I. Situation Overview

On 18 July 2024, a fire incident occurred at Brgy. Guizo, Mandaue City. The fire was declared out at around 2:54 PM.

II. Status of Affected Areas and Population

A total of **91 families** or **355 persons** were affected in **Brgy. Guizo, Mandaue City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **91 families** or **355 persons** sought temporary shelter in **Mayor A. S. Fortuna Memorial Elementary School** in **Brgy. Guizo, Mandaue City** (see Annex B).

IV. Damaged Houses

A total of **55 houses** were damaged; of which, **50** are **totally damaged** and **five (5)** are **partially damaged** in **Brgy. Guizo, Mandaue City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱1,388,850.00** worth of assistance was provided to the affected families composed of **₱875,850.00** from **DSWD** and **₱513,000.00** from the **Local Government Unit (LGU)** (see Annex D).
