

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Pan-ay, Clarin, Misamis Occidental

22 March 2025, 6PM

I. Situation Overview

On 24 January 2025 at around 9:40 PM, a fire occurred at Purok 4, Brgy. Pan-ay, Clarin, Misamis Occidental. The fire was declared out at around 10:00 PM. Due to this, three (3) individuals were affected resulting in partial damage to their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) X, in close coordination with the Local Government Unit (LGU) of Clarin, Misamis Occidental, immediately provided food and non-food items (FNIs) to the affected individuals to support their immediate needs.

A total of **two (2) families** or **three (3) persons** were affected in **Brgy. Pan-ay, Clarin, Misamis Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **three (3) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **partially damaged** in **Brgy. Pan-ay, Clarin, Misamis Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱25,836.00** worth of assistance was provided to the affected families; of which, **₱15,836.00** from **DSWD** and **₱10,000.00** from the **LGU** (see Annex D).
