

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Pangasugan, City of Baybay, Leyte

19 March 2025, 6AM

## I. Situation Overview

On 11 February 2025 at around 5:30 AM, a fire incident occurred at Purok 4, Brgy. Pangasugan, City of Baybay, Leyte and it was declared out at around 07:05 AM.

The incident has led to displacement of a family with a corresponding number of 11 individuals. Among them, five (5) were identified as solo renters.

In response, the DSWD Field Office VIII provided financial assistance through Assistance to Individuals In Crisis Situations (AICS) to support the immediate needs of the affected family and individuals.

A total of **P60,444.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
