

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Santor, Rizal, Kalinga

16 March 2025, 6PM

I. Situation Overview

On 29 January 2025 at around 9:00 AM, a fire incident occurred in Brgy. Santor, Rizal, Kalinga.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) in the Cordillera Administrative Region (CAR), in coordination with the Local Government Unit (LGU) of Rizal, Province of Kalinga, provided relief assistance to address the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **seven (7) persons** were affected in **Brgy. Santor, Rizal, Kalinga** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **(7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Santor, Rizal, Kalinga** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱66,497.83** worth of assistance was provided to the affected families composed of **₱40,197.83** from **DSWD**, **₱16,300.00** from the **Local Government Unit (LGU)**, and **₱10,000.00** from **Non-Government Organizations (NGOs)** (see Annex F).
