

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Cugman, Cagayan de Oro City

as of 14 March 2025, 6PM

I. Situation Overview

On 21 January 2025 at around 2:30 PM, a residential fire occurred at Zone 3, Kalye Limog-mog, Brgy. Cugman, Cagayan de Oro City. The fire escalated to a second alarm at 2:39 PM and was brought under control by 3:17 PM. It was officially declared out at 3:35 PM.

Relative to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region X, together with the Local Government Unit (LGU) of Cagayan de Oro City, promptly provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **14 families** or **42 persons** are affected in **Brgy. Cugman, Cagayan de Oro City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are seven (7) families or 21 persons who sought temporary shelter in Cugman Elementary School in Brgy. Cugman, Cagayan de Oro City (see Annex B).

IV. Damaged Houses

A total of **10** houses were damaged; of which, four (4) are totally damaged and six (6) are partially damaged in Brgy. Cugman, Cagayan de Oro City (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of ₱175,420.00 worth of assistance was provided to the affected families composed of ₱119,420 from DSWD and ₱56,000.00 from the Local Government Unit (LGU) (see Annex F).
