I. Situation Overview

On 28 February 2025 at around 4:17 PM, a fire incident occurred at Sitio Basagan, Brgy. Curuan, Zamboanga City. The fire was declared out at around 4:54 PM.

A total of **10 families** or **48 persons** are affected in **Brgy. Curuan, Zamboanga City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **10 families** or **48 persons** currently taking temporary shelter in **Barangay Curuan Evacuation Center** in **Zamboanga City** (see Annex B).

IV. Damaged Houses

A total of **eight (8) houses** were **totally damaged** in **Brgy. Curuan, Zamboanga City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,100.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
