I. Situation Overview

On 08 March 2025 at around 4:55 AM, a fire incident occurred in Brgy. Infante, Molo, Iloilo City. The fire was declared out at around 5:25 AM.

A total of three (3) families or 12 persons are affected in Brgy. Infante, Molo, Iloilo City (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are two (2) families or nine (9) persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of three (3) houses were damaged; of which, two (2) are totally damaged and one (1) is partially damaged in Brgy. Infante, Molo, Iloilo City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,340.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
