

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Magallanes, Tayug, Pangasinan as of 18 March 2025, 6PM

I. Situation Overview

On 25 February 2025, at around 9:00 AM, a fire broke out and completely gutted a residential house in Purok 6, Barangay Magallanes, Tayug, Pangasinan. The house was declared partially damaged, affecting one (1) family consisting of five (5) individuals, three (3) of whom were reported as casualties. The affected family opted to remain in the remains of their damaged home, while the Local Government Unit of Tayug continues to oversee and assist with their current needs and condition.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, immediately provided financial assistance to support the needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** are affected in **Brgy. Magallanes, Tayug, Pangasinan** (see Annex A).

III. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Magallanes, Tayug, Pangasinan** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱90,000.00** worth of assistance was provided to the affected family composed of **₱15,000.00** from **DSWD** and **₱75,000.00** from the **Local Government Unit (LGU)** (see Annex C).
