I. Situation Overview

On 23 March 2025 at around 7:34 PM, a fire incident occurred in Brgy. Paknaan, Mandaue City. The fire was declared out at around 8:04 PM.

A total of **244 families** or **805 persons** are affected in **Brgy. Paknaan, Mandaue City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **244 families** or **805 persons** currently taking temporary shelter in **Gymnasium** in **Brgy. Paknaan, Mandaue City** (see Annex B).

IV. Damaged Houses

A total of **178 houses** were damaged; of which, **177** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Paknaan, Mandaue City** (see Annex C).
