I. Situation Overview

On 04 March 2025 at around 2:28 PM, a fire incident occurred in Brgy. Tuktukan, Taguig City. The fire was declared out at around 5:23 PM.

A total of **96 families** or **360 persons** are affected in **Brgy. Tuktukan, Taguig City** (see Annex A).

Inside Evacuation Center

There are **96 families** or **360 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Brgy. Tuktukan, Taguig City** (see Annex B).

IV. Damaged Houses

A total of **24 houses** were **totally damaged** in **Brgy. Tuktukan, Taguig City** (see Annex C).
