

DSWD DROMIC Report #2 on the Armed Conflict in Maguindanao del Sur

as of 21 March 2025, 6PM

I. Situation Overview

On 8 March 2025, at approximately 4:00 PM, several families from Barangay Malingao and parts of Barangay Bialong in Shariff Aguak, Maguindanao del Sur, were compelled to evacuate their homes due to the imminent threat of an armed conflict between two opposing groups.

The situation escalated on 9 March 2025, at around 11:00 PM, when a firefight between the rival factions intensified, resulting in a significant increase in the number of displaced families. This further forced many residents to seek refuge in neighboring municipalities, including Shariff Saydona Mustapha.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XII, in coordination with the concerned Local Government Units (LGUs), provided assistance to the affected families to address their immediate needs.

II. Status of Affected Areas and Population

A total of **3,323 families** or **16,615 persons** are affected in **eight (8) barangays** in **Maguindanao del Sur** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are 853 families or 4,265 persons who sought temporary shelter in six (6) evacuation centers in Maguindanao del Sur (see Annex B).

b. Outside Evacuation Center

There are **15 families** or **75 persons** temporarily staying with their relatives or friends (see Annex C).

 c. Total Displaced Population There are 3,323 families or 16,615 persons still displaced in Maguindanao del Sur (see Annex D).

IV. Damaged Houses

A total of **15 houses** were **totally damaged** in **Maguindanao del Sur** (see Annex E).



V. Cost of Humanitarian Assistance Provided

A total of **₱2,375,945.00** worth of assistance was provided by **DSWD** to the affected families (see Annex F).
