# I. Situation Overview

On 19 February 2025 at around 11:00 PM, a fire incident occurred at Zone 3, V. Castro St., Brgy. Carmen, Cagayan de Oro City. The fire was declared out at around 12:36 AM.

A total of **12 families** or **22 persons** are affected in **Brgy. Carmen, Cagayan de Oro City** (see Annex A).

# III. Status of Displaced Population

#### **Inside Evacuation Center**

A total of **seven (7) families** or **12 persons** sought temporary shelter at the **Brgy. Carmen National High School** in **Cagayan de Oro City** (see Annex B).

# IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Carmen, Cagayan de Oro City** (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of ₱157,092.00 worth of assistance was provided to the affected families; of which, ₱100,008.00 from DSWD and ₱57,084.00 from the Local Government Unit (LGU) (see Annex D).
