

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Mantuyong, Mandaue City as of 06 March 2025, 6AM

I. Situation Overview

On 03 March 2025 at around 2:58 PM, a fire incident occurred in Brgy. Mantuyong, Mandaue City. The fire was declared out at around 4:42 PM.

A total of **120 families** or **585 persons** are affected in **Brgy. Mantuyong, Mandaue City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **120 families** or **585 persons** currently taking temporary shelter at the **Gymnasium** in **Brgy. Mantuyong, Mandaue City** (see Annex B).

IV. Damaged Houses

A total of **82 houses** were **totally damaged** in **Brgy. Mantuyong, Mandaue City** (see Annex C).
