

DSWD DROMIC Report #3 on the Fire Incident in Brgy. Mantuyong, Mandaue City

as of 06 March 2025, 6PM

I. Situation Overview

On 03 March 2025 at around 2:58 PM, a fire incident occurred in Brgy. Mantuyong, Mandaue City. The fire was declared out at around 4:42 PM.

II. Status of Affected Areas and Population

A total of **160 families** or **583 persons** are affected in **Brgy. Mantuyong, Mandaue City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **160 families** or **583 persons** currently taking temporary shelter at the **Gymnasium** in **Brgy. Mantuyong, Mandaue City** (see Annex B).

IV. Damaged Houses

A total of **77 houses** were damaged; of which, **75** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Mantuyong**, **Mandaue City** (see Annex C).
