I. Situation Overview

On 28 February 2025 at around 7:00 AM, a fire incident occurred in Brgy. 13, City of Victorias, Negros Occidental.

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 13, City of Victorias, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,499.28** worth of assistance was provided to the affected family; of which, **₱7,399.28** from **DSWD** and **₱2,100.00** from the **Local Government Unit (LGU)** (see Annex D).
