### I. Situation Overview

On 24 February 2025 at around 3:30 PM, a fire incident occurred in Brgy. Abiera, Sebaste, Antique. The fire was declared out at around 6:11 AM.

### IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Abiera, Sebaste, Antique** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱13,806.88** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
