I. Situation Overview

On 09 March 2025 at around 7:51 PM, a fire incident occurred in Brgy. Alijis, Bacolod City, Negros Occidental.

One (1) house was totally damaged in Brgy. Alijis, Bacolod City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,790.00** worth of assistance was provided to the affected family composed of **₱6,500.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
