

DSWD DROMIC Report on the Fire Incident in Brgy. Ayala, Zamboanga City

07 April 2025, 6PM

I. Situation Overview

On 18 March 2025, at around 2:54 AM, a fire incident occurred at Mango Drive, Phase 2, Country Homes, Brgy. Ayala, Zamboanga City. The fire was declared out at around 4:59 AM. Due to the incident, seven (7) individuals were affected, significantly damaging their house.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) IX, in coordination with the Local Government Unit (LGU) of Zamboanga City, immediately provided relief assistance to support the needs of the affected individuals.

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Ayala, Zamboanga City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P715.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
