I. Situation Overview

On 17 March 2025 at around 2:48 PM, a fire incident occurred in Brgy. Basak, Cauayan, Negros Occidental.

One (1) family or two (2) persons were affected in Brgy. Basak, Cauayan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (2) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Basak, Cauayan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱8,938.00 worth of assistance was provided to the affected families; of which, ₱5,938.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
