I. Situation Overview

On 17 March 2025 at around 2:48 PM, a fire incident occurred in Brgy. Basak, Cauayan, Negros Occidental.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Basak, Cauayan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,938.00** worth of assistance was provided to the affected families; of which, **₱5,938.00** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
