

# DSWD DROMIC Report on the Fire Incident in Brgy. Bunyasan, Malimono, Surigao del Norte

## I. Situation Overview

On 08 February 2025 at around 3:00 PM, a fire incident occurred at Purok 2, Brgy. Bunyasan, Malimono, Surigao del Norte. The fire was declared out at around 3:50 PM.

One (1) family or seven (7) persons were affected in Brgy. Bunyasan, Malimono, Surigao del Norte (see Annex A).

## III. Status of Displaced Population

### **Outside Evacuation Center**

**One (1) family** or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Bunyasan, Malimono, Surigao del Norte** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱13,681.50 worth of assistance was provided to the affected family; of which, ₱10,681.50 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
