I. Situation Overview

On 19 February 2025 at around 10:20 PM, a fire incident occurred in Brgy. Cabuloan, City of Urdaneta, Pangasinan.

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabuloan, City of Urdaneta, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱26,064.20** worth of assistance was provided to the affected families; of which, **₱25,064.20** from **DSWD** and **₱1,000.00** from the **Local Government Unit (LGU)** (see Annex D).
