

DSWD DROMIC Report on the Fire Incident in Brgy. Camindangan, City of Sipalay, Negros Occidental

04 April 2025, 6AM

I. Situation Overview

On 22 March 2025 at around 11:00 PM, a fire incident occurred at Brgy. Camindangan, City of Sipalay, Negros Occidental. Due to the incident, 10 individuals were affected, resulting in significant damages to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, in coordination with the Local Government Unit (LGU) of the City of Sipalay, provided relief assistance to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **two (2) families** or **10 persons** were affected in **Brgy. Camindangan, City of Sipalay, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Camindangan, City of Sipalay, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,372.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
