

DSWD DROMIC Report on the Fire Incident in Brgy. Camp 7, Baguio City 05 March 2025, 6PM

I. Situation Overview

On 04 February 2025 at around 4:00 AM, a fire incident occurred at Miami Street, Carantes Compound, Brgy. Camp 7, Baguio City.

A total of **eight (8) families** or **14 persons** were affected in **Brgy. Camp 7, Baguio City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **eight (8) families** or **14 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Camp 7, Baguio City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱77,016.20** worth of assistance was provided to the affected families; of which, **₱12,016.20** from **DSWD** and **₱65,000.00** from the **Local Government Unit (LGU)** (see Annex D).
