

DSWD DROMIC Report on the Fire Incident in Brgy. Cresencia Village, Baguio City

27 March 2025, 6AM

I. Situation Overview

On 09 February 2025 at around 5:00 PM, a fire incident occurred at Lot 6 Block 4, BPI Compound, Brgy. Cresencia Village, Baguio City. The fire was declared out at around 5:15 PM. Due to this incident, five (5) individuals were affected, resulting in damages to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) Cordillera Administrative Region (CAR), together with the Local Government Unit (LGU) of Baguio City, provided relief assistance to support the immediate needs of the affected individuals.

One (1) family or five (5) persons were affected in Brgy. Cresencia Village, Baguio City (see Annex A).

III. Damaged Houses

One (1) house was partially damaged in Brgy. Cresencia Village, Baguio City (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱13,194.40 worth of assistance was provided to the affected families; of which, ₱3,194.40 from DSWD and ₱10,000.00 from the LGU (see Annex C).
