

DSWD DROMIC Report on the Fire Incident in Brgy. Culianan, Zamboanga City

19 March 2025, 6PM

I. Situation Overview

On 17 March 2025 at around 7:46 AM, a fire incident occurred at Manuel Drive, Zone 3, Brgy. Culianan, Zamboanga City, Zamboanga del Sur. The fire was declared out at around 8:03 AM.

In response, the DSWD Field Office IX provided family food packs to the affected family.
