

## DSWD DROMIC Report on the Fire Incident in Brgy. Dicamay II, Jones, Isabela

11 May 2025, 6AM

### I. Situation Overview

On 09 March 2025 at around 11:30 AM, a fire incident occurred at Purok 1, Brgy. Dicamay II, Jones, Isabela. Due to the incident, four (4) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) II, together with the Local Government Unit (LGU) of Jones, Isabela, immediately provided relief assistance to address the urgent needs of the affected individuals.

**One (1) family** or **four (4) persons** were affected in **Brgy. Dicamay II, Jones, Isabela** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family** or **four (4) persons** are temporarily staying at their makeshift house (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Dicamay II, Jones, Isabela** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱44,537.35** worth of assistance was provided to the affected family; of which, **₱23,847.35** from **DSWD** and **₱20,690.00** from the **LGU** (see Annex D).
