

DSWD DROMIC Report on the Fire Incident in Brgy. Guinbanga-an, Laua-an, Antique

15 March 2025, 6AM

I. Situation Overview

On 06 March 2025 at around 11:30 AM, a fire incident occurred in Brgy. Guinbanga-an, Laua-an, Antique. Due to the incident, eight (8) individuals were affected resulting in partial damage to their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Laua-an, Antique promptly provided relief assistance to the affected families to support their immediate needs.

II. Status of Affected Areas and Population

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy**. **Guinbanga-an**, **Laua-an**, **Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of two (2) houses were partially damaged in Brgy. Guinbanga-an, Laua-an, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,556.00** worth of assistance was provided to the affected families; of which, **₱9,756.00** from **DSWD** and **₱1,800.00** from the **LGU** (see Annex D).
