I. Situation Overview

On 19 February 2025 at around 4:00 PM, a fire incident occurred in Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental.

One (1) family or three (3) persons were affected in **Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,528.00** worth of assistance was provided to the affected families; of which, **₱5,888.00** from **DSWD** and **₱640.00** from the **Local Government Unit (LGU)** (see Annex D).
