On 05 February 2025 at around 7:15 PM, a fire incident occurred in Brgy. Jose Abad Santos, Catarman, Northern Samar.

IV. Damaged Houses

A total of two (2) houses were totally damaged in Brgy. Jose Abad Santos, Catarman, Northern Samar. (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱20,000 worth of assistance was provided by **DSWD** to the affected families (see Annex D).
