### I. Situation Overview

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

One (1) house was partially damaged in Brgy. Labnig, San Juan, Ilocos Sur (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱35,350.70 worth of assistance was provided to the affected families; of which, ₱15,350.70 from DSWD and ₱20,000.00 from the Local Government Unit (LGU) (see Annex D).
